DEPOSIT

- A deposit of \$100 is required to reserve your wedding date. This is non-refundable. The \$100 will be charged to the contract/Bride's credit card on file.
- Due to the nature of the business, your wedding date cannot be held until a valid card is placed on file, \$100 deposit is made, and a signed contract is received.
- Your \$100 deposit will be applied to the total contract balance.

PAYMENT

- A 20% gratuity will be added to all services.
- Final balance payment in full is due 1-month prior to the wedding date, and will be automatically processed by Modern Wave using the Bride's card on file.
- If we are unable to process final payment, all wedding contract services may risk cancellation in its entirety.

CANCELLATION POLICY/SERVICE OR PARTY CHANGES

- Cancellations and/or changes can be made up to the final payment date without any extra charges.
- No changes to the requested services or numbers of people in the party can be made past the final payment date. After that, you will be responsible for the cost of all services listed in the contract.
- If you cancel under 1-month prior to your wedding day, 50% of the total wedding contract rate will be charged to the Bride's credit card; less non-refundable deposit.
- If you cancel 14 days or less prior to the wedding day, you will be charged 100% of the total wedding contract rate; less non-refundable deposit. This includes no shows of any party member.
- No refunds will be given for day of service changes, cancellations and/or no shows.

WEDDING DAY LOGISTICS

- To ensure completion of all services in the contracted amount of time, a schedule of services and times will be provided by Modern Wave Salon + Spa.
- The first scheduled appointment/s MUST be present and prepared to start at least 15 minutes prior to appointment time.
- Due to scheduling, we cannot extend appointment times.
- Wearing a button down shirt is suggested.
- Please arrive with clean, dry hair, and makeup free.
- Bring any hair accessories, veils and/or flowers you wish to use to your appointments.

- We offer complimentary tea, coffee, and water, but you are invited to bring in any drinks or food that you feel will make your day more special.

ADDITIONAL INFORMATION

- Practice appointments should be made within 2-3 weeks of the wedding day.
- Bride is responsible for making practice appointments.

- Bride's card on file will be automatically charged for any additional fees incurred.
